

Assembly and Operating Instructions

Thank you very much for purchasing a "chair1987". This guide, henceforth referred to as 'this manual', contains the correct handling instructions for our product. Please read this manual carefully before using it.

- Pleasedo not perch lightly on the seat, sit on the backrest or armrests, or sit anywhere other than the center of the seat.
- When standing up, avoid pushing off from the armrests. Instead, place your hands on the upper front legs to lift yourself.
- Assemble the chair according to the instructions in this manual.
 Incomplete assembly can cause accidents such as tipping over, injuries, or damages during use.
- The load capacity serves as a guideline. If force is applied abruptly
 or only to one part of the chair, there could be a risk of injury,
 damage, or accidents even if the load does not exceed the limit.
 Pleaseabsolutely avoid sitting in a way that applies excessive force
 or causes the chair to shake or bounce.
- This product is made from natural solid wood, and may exhibit warping, twisting, or cracking. If these symptoms become significant, discontinue use.
- Before assembly, carefully inspect all parts for damage. If any damage is detected, discontinue use of the chair.
- Place the chair on a flat and stable surface. Placing it on an unstable location could lead to tipping over and potential injury.
- When children are using the chair, caution them not to stand on it, among other things. There is a risk of tipping over or falling off.

Cautions

These precautions are intended to prevent situations where the user or others could be injured, or where the product or other objects could be damaged.

- Assemble and disassemble the product in a spacious area after confirming there are no people around. Parts may come off with force and fly out during disassembly.
- If the product is used on flooring or tatami mats, it could scratch the floor.
- Do not leave the product exposed to direct sunlight or rain for extended periods. The wooden and fabric parts may deteriorate, and the strength of the product may decrease.
- This product cannot be fully washed.
- Do not use the product in muddy areas, wet grass, rivers, etc. Moisture can damage the wood and may cause the product to deteriorate.
- Do not leave the product near fireplaces or other sources of fire for extended periods. It may catch fire or become deformed.

- We cannot assume responsibility for injuries, damages, accidents, etc., resulting from misuse, usage conditions, or inadequacies in maintenance management and inspections.
- Due to the nature of the product, warping, cracking, and expansion/ contraction of the wood can occur over time and with changes in seasons or places of use. This may make assembly or disassembly impossible. If this happens, do not force assembly or disassembly. Instead, refer to the support page on our website for guidance. Unless the product is defective upon receipt, we cannot accept returns, issue refunds, or provide free replacement parts in such cases.
- We cannot assume responsibility for injuries, damages, accidents, etc., that occur if the customer has modified the product themselves and used it.



If we determine that the issue is due to a manufacturing defect, we will provide a free replacement or repair. - Issues caused by modifications or painting applied to the product by the customer.
- Problems arising from incorrect usage, storage methods, care, or natural wear and tear over time.

- Other cases where the cause is determined not to be a defect in our manufacturing.


Care Instructions


- After use, wipe off dirt and dust from the wood surfaces with a dry cloth. If the product gets damp, wipe it dry thoroughly and let it dry completely in the shade before storing.
- Never wash the wooden parts of the product with water. This can cause the wood to crack, warp, or deform.
- If the fabric parts are heavily soiled, wipe the surface with a cloth lightly soaked in a diluted neutral detergent (about 5%).
- If you are concerned about dirt on the wooden parts, polish the surface with 240-grit sandpaper. Be careful not to over-sand the parts where the wood joins together (inside the holes or surfaces that meet the round rod holes).
- If you are storing the product for a long period, put it in the dedicated storage bag, avoid direct sunlight, and store in a cool place with good ventilation.


Armrests x2



Seat fixing cord x1









Before Assembly

This product is intricately crafted, especially where wood meets wood (referred to as "tenon"), to ensure it can be used for a long time. This is done to prevent the tenon from loosening over time. Therefore, immediately after purchase or depending on the season, the dowel might be hard to insert into the hole. During assembly, as shown in the figure below, please insert the dowel perpendicularly into the hole while rotating it.







- •There is a risk that the dowel could be forcefully pulled out, or that it could hit people or objects during assembly. Please make sure you're in a spacious area and check for people or objects around before proceeding.
- •If it requires considerable force to insert while rotating, or if it's difficult to insert, do not force it in. Instead, use #150 sandpaper to smooth the part of the dowel that will be inserted (the slender part) until it can be inserted easily.























Assembly Instructions

- Please ensure that the product is properly assembled before use.
- Adjust the backrest to the person sitting, moving the wrapped part towards the front leg side. (It will not move once weight is applied.)
- To disassemble, follow these instructions in reverse order.

About Painting

We recommend applying a finish to the wooden parts of this product.

Painting can prevent dirt and degradation, and can improve the appearance and feel of the product. We will introduce some recommended painting methods that bring out the natural feel of the wood, so please refer to the paint manufacturer's website for detailed painting methods.

"Oil Finish"

Many finishes available on the market, including those derived from natural sources, are health and environmentally friendly. It is relatively easy to paint and recommended. Please use oil intended for furniture finish.

"Wax"

Bee's wax and other natural waxes are safe. They are very easy and safe to apply.

(Note)

Please do not use paints that form a film (such as urethane paint, varnish, paint, etc.). There is a risk that you will not be able to assemble this product. We recommend finishes that penetrate into the wood, such as oil or wax.
